Minutes of Meeting Wednesday, January 10, 2024

In Attendance:

2. Motion 2024 – 327 DM Morgan / Councilor Gushue

Moved to adopt the agenda as circulated. All in favor. Carried.

5. Delegation- and was given the floor 7:07
Residents explain that Brake Heights is listed in the Snow clearing contract that was signed on December 15, 2023. Residents would like to know why they are no longer plowing Brake Heights but it is on the signed snow clearing contact. Residents also mentioned that they were given a months' notice that they have to bring their garbage to the bottom of the hill effective November 1, 2023. Why didn't they get this notice with the snow clearing.

Council explained to the Brake Height residents that they had been contacted by the contractor and was told that Brakes heights was not safe to plow. Councilor Bursey and Mayor Parsons visited the area and both felt that the road was not safe. Council had discussed at the December 19, 2023 meeting and made the decision to advise the contractor there would no longer be snow clearing on Brake Heights. Council also explains that there was a guard rail that had been taking down by a resident that owns property there and it would need to be replace.

arrived to meeting 7:20 pm

Resident stated right now they can't get oil delivered to their address because the hill is not being snow cleared. Resident also told council the same contractor has been doing the snow for years, so why the change now. Residents also asked why no work gets done to that road, there is no ditches for water run off and the summer time the road is ruff and no work gets completed like other roads.

Council explained to the Brake Heights residents that they will contact the contactor again and see what the contactor got to stay and will advise what the contactor got to say.

stated to council that she was asked to represent 40 people in the Subdivision on the water supply issue, the color of the water and the fact that there are residents that can't use the dishwasher and washer at the same time. They done have a lot of pressure in the subdivision. The residents would like to be more informed and have a better understanding of what is being down to fix this issue.

arrived to meeting 7:28 pm

We informed that we have applied for a capital works and have not heard back on their decision at this current time. The cost of this project is anywhere between 4-5 Million dollars. had asked what engineering firm we were using, and council had informed All North. also wanted to know if the town had the 20 percent for the capital works project if the town got approved and we informed that the town does have the 20 percent of the funds needed. Mayor Parsons passed along that we have over a million in accounts at this current time.

told council that she went and looked at the Irishtown water supply that she was sent and can see why the water is discolored at times more than some more.

also asked Council if the town got a plan in place for the years to come. Bennett spoke and explain that we have an asset management plan for the towns infrastructure.

discussed a PWDU (Potable Water Dispensing Unit) which can supply drinking water to residents, it a station where you come to the building and fill reuseable bottle with clean drinking water. The average cost is \$375,000.00. Council told this was researched by our planner Cox and we would need to apply though the Capital works program.

asked about further development in the area, because there is currently not enough pressure on the water to have dishwasher and washer going at the same time. Council will not be selling anymore lots in the area till the water supply is greater in the area. The only houses that will be built in the area now are on the land that has already been sold.

Bursey asked if public updates would be informative. They all agreed in the gallery it would be great to have information sent out and to know what is going on and what is being done.

Question from : asked would town take a loan to have the water issue addressed in the town if the capital works grant don't go though. The answer was yes, they have to go to Municipal Affairs for approval before they could go that route.

- The fire dept election is coming up soon. The Chief reached out to their department's liaison McAuley to have brought to Council of the idea of also having the Assistant Chief appointed the same as the Chief gets appointed. The Department can't have an acting fire chief, council can have a person in charge when the Chief is on leave from the department. Council had talked about maybe setting a timeline on the chief and assistant that after so many years you would have to send in a resume for the position. The chief is looking for more information on what other departments are doing for the assistant chief position. Council will have the election go ahead as the department always have and next election will ask for resumes from the department and appoint the positions. Will defer this matter.

- -The new rescue pick-up is ordered, and the accessories parts should be in sometime February.
- The Wildfire grant has been sent to Chief and Cox will go over this with him to get the grant application filed.

- Cox explained to council that though her research fire hydrates should only be flushed twice a year between May and October.

- Cox is coordinating a time with to have a meeting with staff on the water issue.
- Clerk Bennett is going to look into having the roads plowed on a regular basis to the Chlorine buildings.

- 1. Resident concern with lack of lighting at the intersection at the top of Shamrock, where the roads of Paddy Drive, Clover and Celtic Meet. Council had discussion and right now there is no infrastructure at this location but will view the area for decision.
- 2. Resident send email regarding the color of the water in the Summerside area. Clerk Bennett informed council that Maintenance went to the Chlorine building and turned up the Choline for the Summerside area after this complaint. Cox made comment that since they did the adjustment to chlorine, she had seen a difference. Will send letter to resident to advise the adjustment was made to the levels. Will also ask resident in the letter if they have seen any improvements.
- 3. Compliant of the water quality on Facebook. This was addressed at the start of the meeting with the delegation.
- 4. Crown land application for land to add a well and Septic System to property. Council approved this with stipulation they have approval to go through their neighbor's property and approval from Department of Health.
- 5. Resident concerned about the further development of Clover Street due to the resident having a personal well in the area and when work was being done in the area of Clover before they had some discoloration. Will send letter to resident advise there are no plans for new development in the subdivision area until adequate infrastructure is established.
