The Fire Departments honorarium was completed, they will receive \$5.00 for meeting/call/training and a \$500.00 tax break for 100 hours.

Motion 2023 - 315 Councilor McAuley / Councilor Taylor

Motion to amend H.I.S. Honorarium – All members that meet all required stipulations will be entitled to a municipal tax break in the amount of \$500.00 to be applied towards their municipal taxes to the Town of Irishtown-Summerside. The term for each period will be November 30 – November 30. For members that do not reside in the Town of Irishtown-Summerside, existing members prior to October 19, 2022, will be grandfathered in, any members that joined the department after October 19, 2022, will not qualify for the tax credit incentive. To qualify, members are required to have a minimum total number of 100 hours, which includes a requirement of a minimum of 20 meetings/training (which is equivalent to 60 hours). All qualifying members will receive \$5.00/call/meeting/training, etc. to be paid in December of each year.

Councilor Bursey returned 8:42

Project Organizer Cox explained that they have a Chev truck on hold for the Dept. Fire Services wanted a Ford because they would be able to have 4 SCBA seats and they are only able to put 3 SCBA seats in the Chev. The Ford would have to be ordered and would take close to a year. So, they agreed to move forward with the Chev which will have 3 SCBA seats in the truck. The estimated equipment cost is \$53,000.00 they say this truck will be top of the line when completed. The estimated total will be \$144,765.00 and this excludes the cost of the 911 seats which are estimated to be \$25,000.00. This truck will

be 80/20 cost share for the town. The fire dept have been doing fundraising for a new rescue unit.

Motion 2023-316 Councilor Taylor / Councilor Hackett

Motion to except the cost sharing arrangement for new fire fighting vehicle based on an 80/20 Provincial/Municipal ratio as proposed by the Government of Newfoundland and Labrador — Department of Justice and Public Safety. Council will collect all funds raised by H.I.S. Fire Rescue fundraisers that were intended for the purchase of the new vehicle. All in favor. Carried.

7. Correspondence

- 1. Resident complaint on the water flowing down hill and pooling in front of her house, Council discussed this matter. Will send letter to resident and advise resident this is not a town issue and resident will need to look into drainage.
- 2. Resident reached out to the office to about the concern of neglected, lost animals in the community. This is out of the town means. Will thank resident for reaching out.
- 3. Letter from Minister of Health and Community services looking for Municipalities to be a distribution site for Naloxone kits. Council disused and will pass due to the safety concerns.
- 4. Norten will no longer be offering flow meters rental service. The town would have to purchase their own flow meters and Norten would service.

- There is also a Fire smart program that Project Organizer will pass along to the Chief.
- Recreation has cancelled their last couple of meetings. Recreation is required to have one meeting a month, will advise recreation of this to be looked at in January.
- a) Clerk Bennett mentioned to council that we need storage for road signs and other items that are currently outside in the weather. Suggestion of a Sea can on the far side of the garage would work for these items. Councilor Gushue will look into the price for council.
- b) Resident spoke about the garbage can being removed from the mailboxes in Summerside. Currently there is a blue bin with a lid in the area. Will have signed place on the bin to advise residents they can place flyers inside.

11. Late Items
